## SHARP Corner

#### 2019 and 2020 HRA Claims Deadlines

2019 claims may still be submitted, but only until March 31, 2021, and must be done on paper claims forms. You can download and print a form by logging into your Aon account. If you haven't yet set up your online account at retiree.aon.com/adventistretirement, now is a good time.

You can also get claim forms by calling 844-360-4714. Keep in mind that Catastrophic HRA claims have a separate form and you will need to call the above number to request the form. The deadline for 2020 claims (which may be filed via the online portal) is December 20, 2021.

#### **HRA Requirements and Eligibility**

This is our fifth year in the marketplace world where retirees are working with Aon Retiree Health Exchange to enroll in a medical and/or prescription drug plan. As a reminder, you must be enrolled through Aon continuously to maintain your HRA eligibility. **NOTE:** This means if you switch from Aon to a local agent or someone you were referred to, and no longer have an active enrollment through Aon, you will permanently forfeit your HRA eligibility.

#### Medicare and COVID-19—Just So You Know!

Per https://www.medicare.gov/medicare-coronavirus, Medicare covers the following expenses related to COVID-19:

- ▶ Lab tests for COVID-19
- ► FDA-authorized COVID-19 antibody testing if you were diagnosed with a known current or prior COVID-19 infection
- ▶ Monoclonal antibody treatments for COVID-19
- ▶ COVID-19 vaccines: You pay no out-of-pocket costs
