#### **Supplemental Healthcare Adventist Retirement Plan**

appy New Year from your SHARP team! And since it's January, we know that you are facing new deductibles for your healthcare benefits, and if you're enrolled through Alight Retiree Health Solutions, replenished funding for the year!

Alight enrollees may also have new premium amounts. Remember that if you are on auto-reimbursement, it takes about six weeks for the new rate to get from your insurance company to **Alight to update.** Reimbursement at the 2022 rates continues until your insurance company has updated Alight with the new premium amount for 2023. Once received, your next reimbursement will be adjusted to ensure you are accurately reimbursed using the new rate. If you don't want to wait, you may always manually update your reimbursement amount through your online account.

The happy news for those over the age of 65 is a reduction in both Medicare B premiums and the deductible. The table on the right shows a few highlights for the new year.

For those receiving a monthly benefit from our office, be sure to watch for the statement from our payroll department coming at the end of January. It lists your SHARP contributions and the Additional Church Pension Supplement for those who qualify. Keep this statement for verification of income throughout the year.

#### **Medicare Participants (age 65+)**

| Medicare A deductible        | \$1600   |

#### Medicare D deductible (Prescription)

\$505—this is a maximum amount. Some plans will have a lower deductible, and some will even have a \$0 deductible. Check your Plan document for your specific information.

#### **Regarding SHARP Dental/** Vision/Hearing cost increase for 2023

I hile the actual cost of SHARP DVH in 2023 is \$105/month/ person, the cost to the retiree is only going up \$3/month per person.

Remember that you have always received an earned credit to offset the cost from what you pay. We apologize for any confusion.
