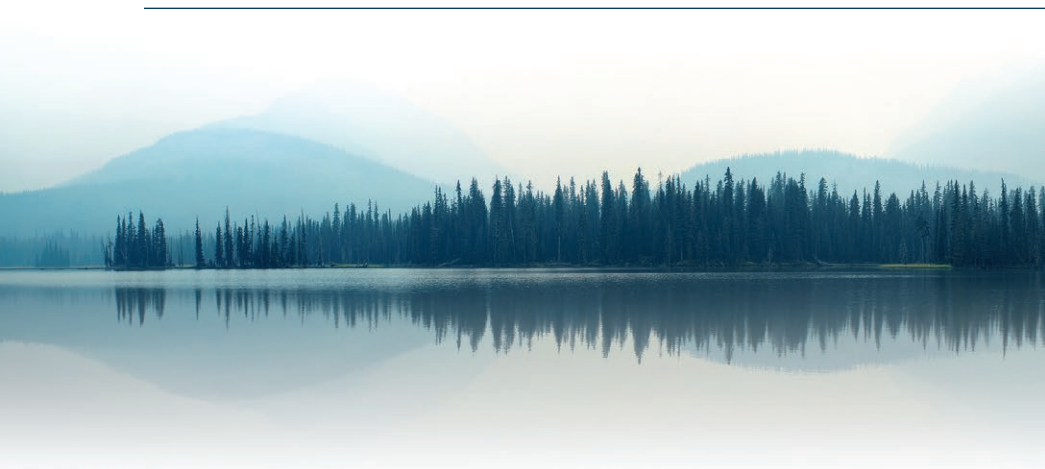

the classes. I also set up several databases for various departments and I assisted employees with software issues throughout the GC building.”

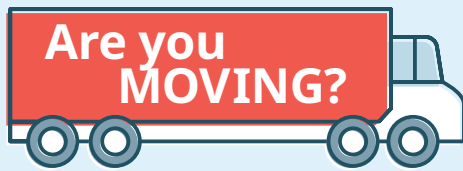

### REMEMBER THESE STEPS:

- ▶ IF YOU HAVE MOVED TO A NEW STATE OR COUNTY you must call Alight Retiree Health Solutions before updating your address for MediGap, Medicare Advantage or Medicare Part D insurance carrier. Alight will help you choose a new insurance carrier in the state or county you have moved to. **To contact the Alight Retiree Health Solutions, phone 1-844-360-4714.**
- ▶ If you don't call Alight first, you could unintentionally disenroll yourself (yikes!) from the Alight plans and thus lose your Health Reimbursement Account (HRA) money for the future.
- ▶ You also need to make an address correction with the Social Security Office.

## SHARP Corner

(Supplemental Healthcare Adventist Retirement Plan)

### April 30, 2023 is the deadline to submit 2022 expenses to Your Spending Account (YSA).

To access and manage your Health Reimbursement Account (HRA) online, log into your account at [www.retiree.alight.com/adventistretirement](http://www.retiree.alight.com/adventistretirement). Click on My HRA in the My HRA section of the home page and then click on the "Manage My HRA" button. All the information to manage your account may be found by logging into your Alight Retiree Health Solutions account. There, you can view and manage your account such as balance, submitting claims and documentation, status of your claims and reimbursements, and eligible expenses. You may also adjust the monthly reimbursement amount you receive.

If you have questions about claims, the deadline, or need assistance, contact Alight Retiree Health Solutions/YSA at 1-844-360-4714. ■

### REMINDER: Catastrophic HRA Benefit Qualifications

The deadline to submit 2022 claims for the Catastrophic HRA benefit is April 30, 2023. If you frequently use prescription drugs, you may reach the Medicare Part D catastrophic coverage limit. While most retirees are unlikely to reach this limit, if this impacts you, you are eligible for the Catastrophic HRA. Once you've received a Medicare Explanation of Benefits (EOB) showing your Part D out-of-pocket maximum (\$7,050 in 2022, \$7,400 in 2023) has been reached, call YSA at 844-360-4714 and request a Catastrophic HRA claim form.

YSA will initiate the Catastrophic HRA process once they receive your claim form and the EOB. You will be reimbursed for prescription claims for the remainder of the calendar year. There's no annual limit to this benefit and you do not need to exhaust your standard HRA first. ■
